Completing a Statutory Declaration of Identity

Sometimes a client needs to have their identity verified, but is unable to do so because they do not have any of the documents used for identity in New Zealand (Passport, Driver's Licence or Firearms Licence). For example a person fleeing violence may not have been able to get access to their ID or a catstrophe like Cyclome Gabriel may have destroyed their ID.

In this instance the client can complete a Statutory Declaration to state their identity.

On the following pages, there are 2 Statutory Declaration forms that can be used for this purpose.

The first is a form to use if the client has a photo of themselves.

The second is a form to use if the client does not have a photo of themselves.

For both of these situations, you can also use the generic Statutory Declaration form if the client puts the required wording in the declaration box. If they have a photo of themselves, you can attach this as an Exhibit. If they have a birth certificate you can attach this as an Exhibit also.

The generic Statutory Declaration form can be found online if you Google "Statutory Declaration form NZ".
