# 2. Professional Development Update

Some of you will recall me introducing myself recently, as a new member of the Council. I just wanted to also let you know that I have assumed responsibility for the Ministerial Professional Development Portfolio for our Wellington JP Association.

Thank you to everyone who found the time to attend training for the first 3 sessions of the year where we dealt with affidavits. It was particularly pleasing to get a bumper turnout (39) at the Kapiti presentation of this training theme.

It is really encouraging to see training and accreditation being prioritized by our association members. Do remember if you did attend one of these sessions to record it in your Federation online profile to keep your JP accreditation up to date. Please also do just monitor your due date to retake the accreditation test which, as I am sure everyone knows, is valid for 24 months from when you last passed the test.

For the next segment of 3 opportunities, starting at 09:30 21<sup>st</sup> June 2025, at Whitireia in Porirua, we will look at the wider roles available to JPs, where we will hear from a panel of JPs involved in some of those roles. We will also examine a couple of general scenarios for group discussion. This session will be repeated at Wellington District Court on 15<sup>th</sup> July 2025 at 5:15pm, and again, at Waikanae Community Centre, on 15<sup>th</sup> August 2025 at 9:30am.

While the current plan for the last 3 sessions of the year (Sep/Oct/Nov) is to present a session on marriage dissolution, I am keen to hear from you, if there are other things that you consider more pressing, more topical, or which might address trends or challenges which you are experiencing in your day-to-day activities as Ministerial JPs. If I hear a groundswell, favoring a higher priority, I will certainly consider adjusting the forecast plan for those last 3 sessions of the year to meet the demand.

On a similar vein I am interested to hear from anyone, as we approach the second half of the year, about any subjects you would like to have addressed in the training plan for 2026. # 4. Wellington JP Honoured in King's Birthday Honours List

We are proud to share that one of our members Sunit Prakash, and his wife Lalita Kasanji have been recognised as Members of the New Zealand Order of Merit in the King's Birthday 2025 Honours List for services to the IT industry and the Indian community.

Since 1995 New Zealand has recognised only about fifteen recipients for services to Information Technology. This is the very first awarded to members from the Indian community.

The husband-and-wife duo co-founded the <u>New Zealand Centre</u> <u>for Digital Connections with India</u> in 2023 to accelerate and incubate digital and tech collaboration between the two countries.



In a rare trifecta, they follow in the distinguished footsteps of Mrs. Ruxmani Kasanji - Lalita Kasanji's mother - who was awarded a Member of the New Zealand Order of Merit in 2019 for her services to the Indian community.

We warmly congratulate Sunit and Lalita on this well-deserved honour and wish them continued success in their endeavours.

#### **40 Years of JP Services**

As a JP, Lyn has dealt with remands, traffic offence appeals, affidavits of identification of accident fatality, search warrants, mental health at the police station, National Election annexure official count, in addition to the ministerial work she enjoys. She is currently doing home visits if a client is medically incapacitated and needs JP Service and finds Service Desk work interesting and varied.



Lorraine Rainham of Whitby was presented with her

40 Year Certificate along with a gift of appreciation from the Association. Lorraine is an active JP as she is aware how much her service means to her community.

She says the highlight of her JP career so far has been her role as a Judicial JP as she loves understanding how the law works and how to apply it. She has now stepped down from that role and is back working full time

at the Accident Investigation Commission.

In the early 1990s Lorraine became the first female Royal Federation Registrar and worked with 3 Presidents, Stan Hackwell, David Pezaro and Clive Ray.

She says it's a shame JPs don't meet for monthly lunches in the city anymore as it was great way to socialise with colleagues.
